
Sir,

In inviting reference to Memo No.2479/F&E dated.05.02.2018 of Forest & Environment Department, Government of Odisha, I am directed to intimate that the above mentioned project have accorded general approval by Forest & Environment Department vide their letter No.26020/F&E dated.15.12.2015. In the meantime, the Chief Engineer, NHs Odisha, Bhubaneswar vide his letter No.3781 dated.07.05.2018 (copy enclosed) has intimated that the Executive Engineer, NH Division, Bolangir (User Agency) is unable to upload the demand note towards NPV raised by DFO, Subarnapur Forest Division in the web-portal of MoEF & CC, Government of India as the General Approval order has not been uploaded in the web-portal of MoEF & CC, Govt. of India.

In view of the above, it is requested to kindly take appropriate action at Government level so as to enable the User Agency (i.e. Executive Engineer, NH Division, Bolangir) to deposit the NPV amount by using web-portal of MoEF & CC, Govt. of India.



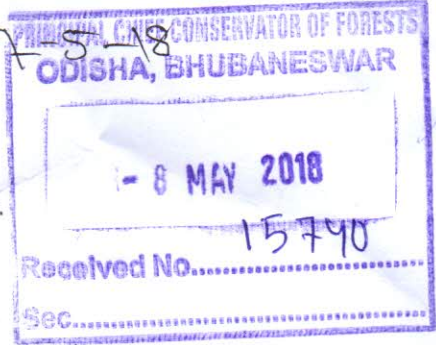

Sir,

In inviting a reference to the above, I am to intimate you that Stage-I clearance of the above proposal has been granted by the Government of Odisha vide letter no 10F(Cons)239/2017/26020 dated 15.12 2017 and in pursuance to this the DFO, Subarnapur Forest Division has raised NPV for an amount of Rs. 63,52,030/- for deposit by user agency by uploading the demand note for approval and generation of Challan online. But the Executive Engineer ,National Highway Division, Balangir (user agency) is unable to transmit the demand note online for approval by the Nodal Officer , due to non-display of the approved proposal in the portal to proceed with stage II level.

On enquiry with NIC, it was understood that, the approval letter should have been uploaded by the Department of Forest and Environment, Government of Odisha which subsequently gets automatically transferred to the Regional office of MoEF ,Bhubabeswar and RO is to close the proposal at stage-1. But instead of it, the approval was communicated to user agency through APCCF-CF-DFO and now the proposal is on reverse transmission from User Agency -DFO-CF-APCCF- Govt of Odisha with present status pending with CF, Bhawanipatna.

It is also further learnt that, due to technical problem, the CF Bhawanipatna region is unable to transmit the proposal to APCCF.

In view of above, I would request your kind intervention in the matter for an early resolution of the software problem for compliance of the conditions contained in stage-1 clearance.




