The point wise compliance to the observation made are furnished below.

I	The Collector, Jajpur has issued FRA certificate for 3.62 ha, within the village limit of Ragada, Ardapal and Forest Block No. 27, whereas the land schedule enclosed in the DP in respect of Khuntaposi, Kumutibahal and Deogaon, So, please clarify and ascertain whether land schedule of the above villages included in the FRA certificate or not.	The Collector, Jajpur has issued FRA certificate for the revune village Ragada, Ardapal and Forest Block No. 27 in Sukinda Tahasil. The villages namely Khuntaposi, Kumutibahal and Deogaon for which diversion proposal is required are coming under Forest block No. 27 for which the Collector, Jajpur has issued FRA certificate. Therefore the land schedule of above villages are included in the FRA Certificate.
2	The road alignment is not shown in the toposheet properly and the toposheet is a cut piece without toposheet No. & scale.	The Toposheet bearing No. F-45-N-12 of scale 1:50000 showing the road alignment is enclosed herewith for reference.
3	The forest land schedule provided in the DP is 1.91 ha whereas the proposed diverted land area is 1.912 ha. So, please clarify it.	The proposed diverted land for the three villages is Ac. 4.723 i.e. 1.91137 ha which may be read as 1.91ha.
