Vide reference 24th cited, the Director (Planning & Projects), M/s SCCL, Bhadradri Kothagudem District has submitted the point wise reply as desired in Minutes of FAC meeting held on 31st March 2022 at GoI, MoEF & CC, New Delhi.

The point-wise information as submitted by M/s SCCL with remarks are furnished as follows:

1. Complete detail of mining leases covered within the approved forest area of 929.29 ha may be provided by the State along with the nature of mining operations i.e., opencast or underground.

Reply:

M/s SCCL has stated that the entire proposed area for 2nd renewal of 929.29 ha forest land is falling in the one Mining lease. Now, Indaram Mining Lease, which has been extended by the Government of Telangana under Mineral Concession Rules -1960 (amended as on 01.10.2021) to an extent of 2044.34 ha (involving 929.29 ha of Forest land) (Copy enclosed) duly extending validity till 28.07.2030. Later, renewal to be obtained for further 20 years. Hence, the permission under F(C)Act, 1980 will be co-terminus with this period.

M/s SCCL has further stated that the proposal for renewal of Mining Lease as well as renewal under F(C)Act,1980 was submitted well before two years from the date of expiry of lease. Hence, as per Rule 24A of Mineral Concession Rules-1960, mining continued under deemed clause extension till State Government issue orders or two years whichever is earlier.

Remarks:

M/s SCCL has applied for 2nd renewal of coal mining lease on 28.05.2018. As per the Para 7.6 of the handbook issued in F.No.5-2/2017-FC, Dt,28.03.2019 and amendments issued therein, extension of Forest Clearance to be given till 28.07.2030 i.e., co-terminus with the mining lease granted by the Government of Telangana, after realization of compensatory levies from M/s SCCL and upon compliance of conditions stipulated in Stage-I approval by M/s SCCL.

- a. M/s SCCL has stated the proposed area of 929.29 ha (leaving surface use of 15.18 ha) is used for underground purpose only. The SCCL submitted proposal to Forest department for 2nd renewal of 929.29 ha (including 15.18 ha surface rights) on 19.07.2018. As on that date, the bifurcation of 929.29 ha of FL is as follows:

- b. The Revised Mining Plans of all the UG mines (RK-6, RK-7 and RK NT were approved vide MOC Lr.No.13016/5/2007-CA-II Dt.17.09.2007, which included in 929.29 Ha.
- c. The Srirampur open cast II project is an operating mine in the neighbouring mining lease of **North Godavari ML** with an annual production of 2.50 MT. Due to increase in demand of coal the SCCL planned to enhance the existing operating opencast mines to enhance the production. Accordingly, Srirampur Opencast-II project was proposed for expansion with annual production of 3.50 MT from 2.50 Mt by adding FL and NFL with name of Srirampur Opencast II expansion project.

As may be observed from the Part-II uploaded on the www.parivesh.nic.in, the Forest Divisional Officer, Mancherial has clearly reported that no violation and it was recommended. Further stated that they have also requested the forest officials in between to process the proposal.

"24C. Period of mining lease granted to Government companies or corporations".

All mining leases granted on or after the commencement of the Mineral Concession (Amendment) Rules, 2021, to a Government company or corporation for coal or lignite shall be for a period of fifty years.

- All subsisting mining leases vested or granted to a Government company or corporation before commencement of the Mineral Concession (Amendment) Rules, 2021 for coal or lignite shall be deemed to have been granted for fifty years or till 31st March 2030, whichever is later.
- 2. The State Government, upon an application made to it in this behalf by the

Government company or corporation at least three months prior to the expiry of the mining lease, shall extend the period of the mining lease for a further period of twenty years at a time.

3. Accordingly, the State Government has now granted extension to Indaram Mining Lease for 50 years to an extent of 2044.34 Ha (Involving 929.29 Ha Forest land) vide G.O.Ms.No.9, Energy (Power. II) Department, dated 16.04.2022 valid upto 28.07.2030. Later, Renewal will be granted for a period of 20 years.

Remarks:

M/s SCCL has applied for 2nd renewal of mining lease on 28.05.2018. As per the Para 7.6 of the handbook issued in F.No.5-2/2017-FC, Dt,28.03.2019 and amendments issued therein, extension of Forest Clearance to be given till 28.07.2030 i.e., co-terminus with the mining lease granted by the Government of Telangana under Mineral Concession Rules,1960 and in accordance with the Mines and Minerals (Development and Regulation) Act, 1957; Coal Bearing Area Act, 1957/ Coal Nationalization Act, 1973/ Coal Blocks Allocation Rules, 2017. Accordingly, the State Government has now granted extension to Indaram Mining Lease for 50 years to an extent of 2044.34 Ha (Involving 929.29 Ha Forest land) vide G.O.Ms.No.9, Energy (Power. II) Department, dated 16.04.2022 valid upto 28.07.2030. Later, Renewal will be granted for a period of 20 years.

Hence, it is requested to kindly recommend and forward this submission made to the MOEF & CC, GOI, through State Government, for grant of extension of forest diversion co-terminus with the mining lease.
