Kindly refer to your office Endst. No. 182 dated 13/4/2023 on the subject cited above.

2. In this context, it is submitted that the point wise reply to the observation raised vide your office letter under reference is furnished as under:-

S. No.	Observations	Reply
1.	As per KML file there are 6 villages to be benefited have been mark whereas, in village wise breakup nly 5 villages have been mentioned.	The user agency has submitted that the necessary correction has been made in online portal Part-I.
2.	The FRA certificate issued by DC as uploaded against the column No. K of Part-I is without signature, hence revised certificate may be uploaded.	The user agency has submitted that the revised certificate of FRA is uploaded in online portal Part-I.
3.	The costs of project as mentioned in online Part-I is mentioned 930 lac. whereas 9.30 lac has been mentioned in the Part-I as uploaded against Sr. No. 2 of additional information detail, correct figures may be given	The necessary correction has been made by the user agency. The actual cost of the project is 9.3 lac (instead of 930 lac) has been uploaded in online portal Part-I.
4.	Executive Engineer has not signed the layout plan of the proposed road as uploaded against Sr. No. 2 of additional information detail Part-I, correct figures may be given.	The signed copy of the layout plan has been found uploaded in online portal Part-I of additional information.
5.	The abstract of enumerated trees as uploaded against Sr. No. 2 of additional information detail of Part-I, is not signed by DFO concerned.	This pertains to DFO Rampur which is also uploaded by DFO Rampur in online portal Part-II.
6.	The penal CA has been proposed in lieu of the forest land already broken whereas penal NPV bill is required to be prepared.	The Penal NPV bill is prepared and uploaded online Portal as additional information of Part-II.
7.	As per the check list No. 7 of the proposal, UPF (un-demarcated protected forests & DPF (Demarcated protected forests) has been mentioned whereas, as per column No. 2 of online Part-II protected Forest & Un-Protected Forests has been mentioned. Necessary clarification/correction in this regard be done.	Necessary correction has been done in the online part-II.
8.	From the perusal of the KML file of CA site is seems that there are already trees on the site, hence the CA site may be reviewed or it must be mentioned in the CA land suitability certificate that proposed CA area is having less then 40% canopy density.	It is submitted that the CA area shown against the proposal having only shrubs and not dense forests as per site report of field functionaries and is also checked through google map by giving GPS Coordinates of the CA area. Hence it is requested that the already submitted CA map may be considered.

It is, therefore, requested that the proposal may kindly be sent to GoI for according necessary approval under section 2 of Forest (Conservation) Act, 1980. Two copies of penal NPV bill & cost of trees are being sent herewith for taking further necessary action at your end please
