In inviting reference to the letter on the subject cited above, I am submitting herewith
the point wise compliance and supporting documents necessary for sanction on the above project for
favour of your kind information and necessary action.

- Observations 1-** Shape and KML file are not appended with the diversion proposal.
Compliance Shape and KML file are enclosed in shape of CD in the Diversion Proposal.
- Observations 2-** In the instant case, the ROR area is 0.890 Ha and the DGPS map area is 0.894
Ha. in form A of Part-I, the user agency has mentioned the forest area proposed
for diversion as 0.894 Ha. Thus, this area should be taken for the diversion
proposal.
Compliance The user agency has submitted a letter vide No. 672/23 date 04.09.2023
(copy enclosed). He has intimated that as per ROR area, 0.890 has been
changed in Parivesh Portal instead of 0.894 as Annexure-I in the Diversion
Proposal, which is now reflected in the Parivesh Portal.
- Observations 3-** Checklist is not countersigned by the RCCF, Baripada Circle.
Which may please be signed.
- Observations 4-** In Sl No.9 of Part-II, the DFO, Baripada division has mentioned implying of
that there is no violation. But in SL No, 18 of Site Inspection Report, he has
mentioned about violation.
- Compliance** The revise Part-II is enclosed in the Diversion Proposal.
