Detail Note on Project

The telecom cables are always laid along the road side due to easy supervision, quick maintenance and low cost of maintenance. Laying of cable shall be done on 0.45m width of surface of land & up to 1.65m of depth and near to extreme road boundary where alignment of trench will be done in such a way that no tree required to be cut. 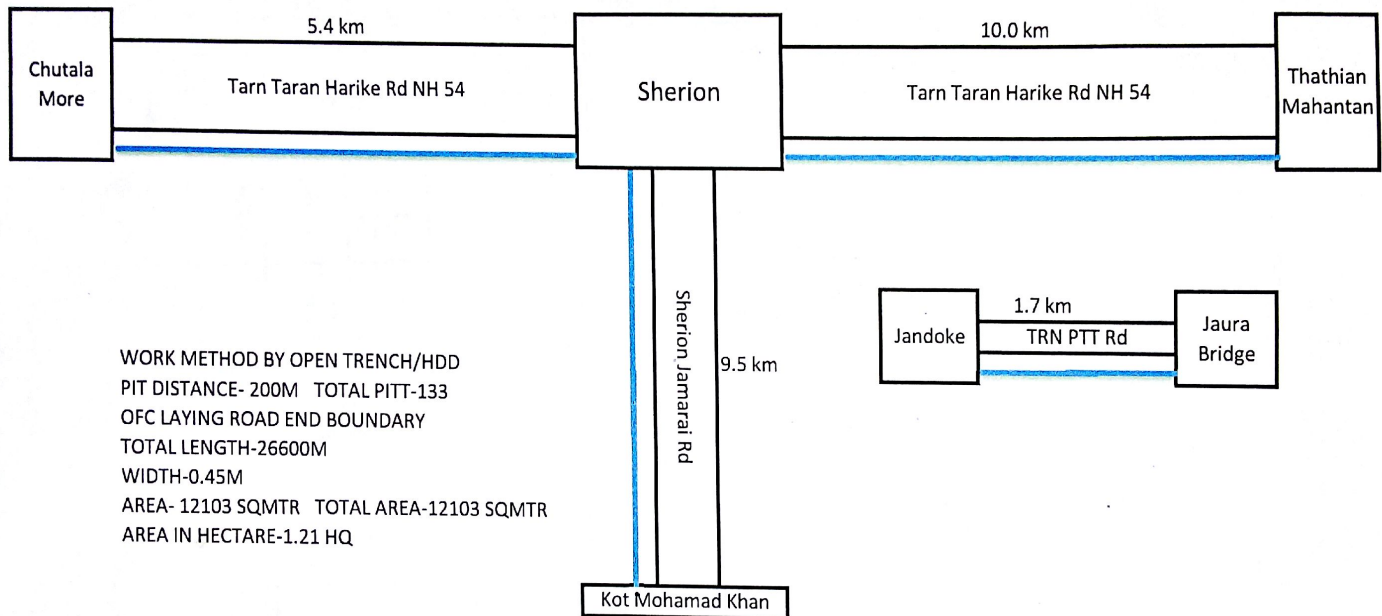

PROPOSED OFC ROUTE OF BSNL AMRITSAR IN NAUSHERA PANNUAN AREA



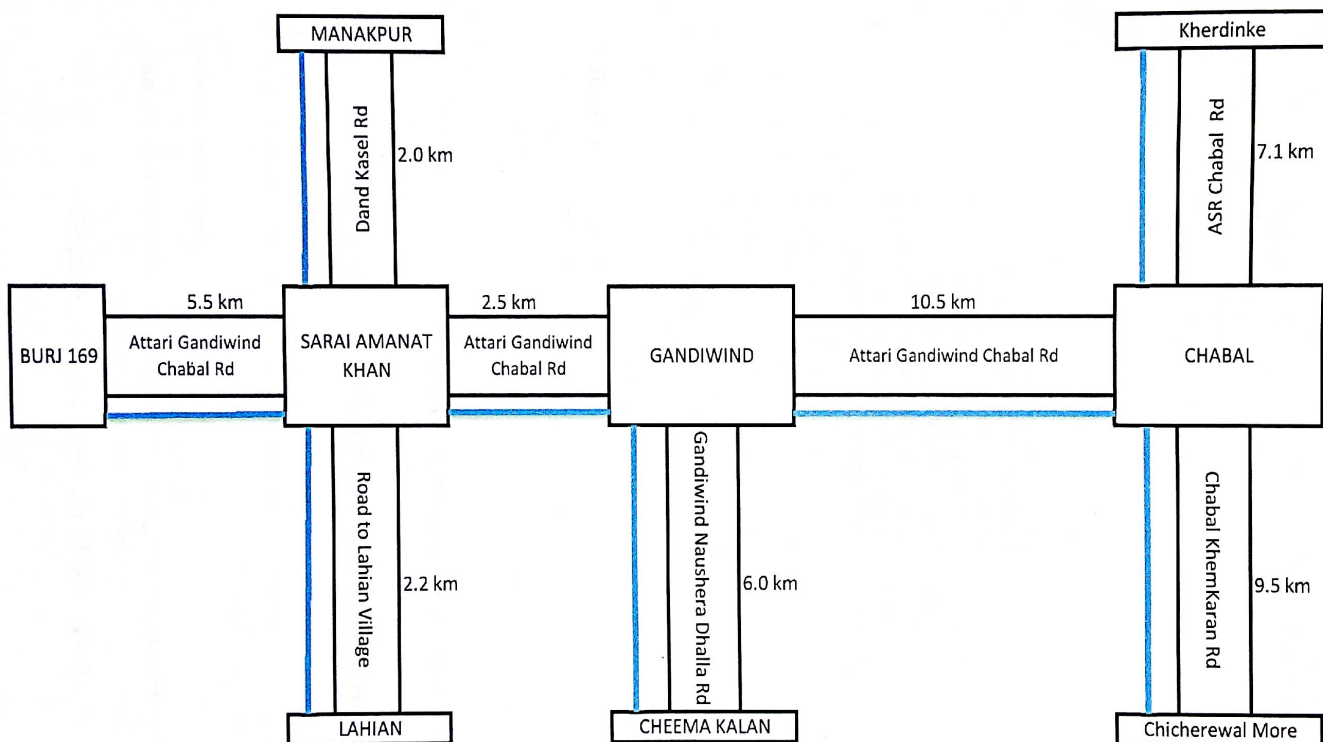
