Sir,

Please refer to the Government of Tripura letter No. F.6-1145/FC/For-2017/1279-285 dated 13th January, 2022 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case: -

- 1) The chronology of events on the violation and the action taken by the State Government. The State Govt may submit a self-contained report of final action on POR filed and action as per para 3 B (iii) & (iv) as per Ministry's letter dated 29/1/2018 as mentioned by it.
- 2) Whether the flattering work has been completed and the area of violation may be specified.
- 3) NPV is to be calculated as per revised rate dated 06.01.2022.
- 4) Cost Benefit Analysis is to be calculated as per revised rate of NPV dated 06.01.2022.
- 5) Sol toposheet map with legends to be resubmitted after duly signed by DFO concerned.
- 6) Status of Forest Right Act, 2006.
- 7) GPS Coordinates of proposed forest land diversion, for each patch.
- 8) Length & Width of railway line.
