Diversion of 1.16 ha of forest land in favour of HPPWD for the construction of link road Dokru-Lehar-Neri Km 0/0 to 2/960 within jurisdiction of Bilaspur Forest Division, Bilaspur, HP.

Sir,


Please refer to your office letter No. 4982-83 dated 13.1.2021 on the subject cited above.

2. From the perusal of proposal folders submitted vide your letter quoted above, the following shortcomings have been noticed:-

1. As per column No. 2 of part-I, total 0.282 ha forest land is required including road and dumping sites. But as per check list Sr. No. 6 and proposal 1.16 ha forest land is required. Please clarify.
2. Some duplicate documents are placed in first proposal folder whereas, it should contain all original documents. The coloured documents of 1st proposal folder should be placed in duplicate folders also.
3. Vide page 8, dumping site is mentioned 0.15 ha whereas in other documents, it is 0.20 ha.
4. The dumping site and alternate alignments are not marked on toposheet.
5. Proposal No. & date is not mentioned in page-21 and signature is also without office seal/stamp.
6. The location of beneficiary villages marked on digital map and KML file are not tallied with each other.
7. As per page 14, the total length of road is mentioned 2.960 meter for which 1.16 ha forest land is required which does not understood.
8. As per check list Sr. No. 6, the dumping site (0.20 ha) is shown in Kh No. 476/408/340 and legal status of forest land is mentioned as UPF whereas as per revenue paper, this Khasra is DPF.
9. In the Resolution of Gram Panchayat, Rohal and Forest Rights Committee, Rohal placed at Page 29 & 30, over writing is made in many places by applying white fluid. Besides this, the GP Rohal has passed resolution in its Gram Sabha meeting held on dated 23.9.2016 whereas, the same is signed by Pradhan & Secretary, GP Rohal on dated 8.2.2018 which needs justification.
10. As per page 36, dumping site is proposed in Gair Mumkin Khad which is not justified.
11. The road is constructed in violation and inspected by the committee constituted under the chairmanship of CCF Bilaspur on dated 27.6.2019. As such, a detailed note on violation depicting year of violation, authority/person responsible for violation, extent of violated area i.e. length & width including area violated in hectares.
12. As per Muck Management plan placed at page-44, 45 & 46 the muck management plan including drawing of dumping site is prepared in respect of c/o link road Dokru to Neri Km.0/0 to 3/0 whereas the above project is for construction of link road Dokru Lehar Neri Km 0/0 to 2/960.
