Ref: This office communication Nos. PCCF/FCA/3415/2728 dated 16-11-2021 and No. PCCF/FCA/3415/4215-17 dated 13-12-2021.

This is with reference to the above proposal and in continuation to this office above referred communications. The Conservator of Forests, Chenab Circle Doda/DFO Marwah/User Agency are requested to upload/clarify the followings within two days:

1. There is mismatch between the involvement of forest area in Part-I and Part-II, as in Part-I, forest area shown as **7.36 Ha** and in Part-II as **7.4783 Ha**. The correct detail of forest area need to be uploaded.
2. In Part-II, under column 2, forest area 7.36 Ha has been filled, whereas in rest of the column 7.4783 Ha. Correct detail need to be filled by DFO Marwah.
3. The Administrative Approval/Sanction of the project, need to be uploaded by user agency.
4. The employment generation detail with the construction of the proposed road has been shown as nil by the user agency. The detail of mandays with the construction of proposed road need to be filled by the user agency in Part-I.
5. In the enumeration lists, plants (0-30 girth) has been shown, whereas detail of the plants has not been shown in Part-II by the DFO.
6. The NPV rates have been revised by the MoEF & CC stands communicated vide this office communications nos. PCCF/FCA/3124/5002-5052 dated 07-01-2022 and PCCF/FCA/3444/5222-5322 dated 20-01-2022, whereas old rates of NPV has been assessed and incorporated in the proposal. The NPV need to be assessed and incorporated in the proposal as per new NPV rates by the DFO Marwah.
