1. Scientific names of some trees are still shown as Misc. Scientific names of trees be uploaded.

Karnal Division

2. Uploaded toposheet is not legible/readable. Legible/readable Toposheet indicating CA site with toposheet No. and duly signed by DFO be uploaded
3. Now detail of 51 trees instead of 61 has been uploaded which needs to be corrected.
4. DGPS Map is still not clear as GPS point not clearly given.

Yamunanagar Division

5. KML file indicates sufficient space for plantation of 2394 no. of plants., However, there seems to be a water body in the middle of the CA site proposed as observed in the latest imagery. This can be rectified and accordingly, revised DGPS map also to be uploaded.
