महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से सम्बंधित संदर्भांकित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए **0.0504** हेक्टेयर वन भूमि की मांग की गई है।

2. प्रस्ताव से सम्बंधित निम्नलिखित जानकारी भेजने का कष्ट करे: -

- As the proposed line passes through the road/canal, NOC from concerned department needs to be submitted.
- Density appears to be more than 0.1 for 35 trees in 0.0504 ha, needs to be corrected.
- Details of saplings not found, the same needs to be uploaded.
- Details of trees that are actually required to be felled and no. of trees proposed for lopping/chopping. In addition, the tree enumeration list in English needs to be uploaded.
- Yes, mentioned at para 5 in part II against working plan details instead of providing the comments.
- No comments made by the DFO in his SIR against column no. 2, 3, 4 & 5.
- Land schedule not found uploaded online.
- Complete kml of route plan needs to be uploaded indicating forest area falling in the alignment.
