2. Certificate mentioning that the status of total land in the Project (Both forest and non-forest) as given in the table is as per Govt. records as on 25.10.1980.
3. CA Scheme should be attached along with DGPS maps in Diversion Proposal.
4. All papers/pages should be signed by the Authorised Signatory of the User Agency.
5. Undertaking regarding FRA certificate is not attached.
6. Topo sheet map, Index Map & Lay out Map should be authenticated by Range Officer.
7. Three alternative Route analysis Maps should be attached.
8. The applied area shown in the Topo sheet Map should be signed by the User Agency and authenticated by the Range Officer, Banki Range.
9. The Layout plan should be authenticated by the Range Officer, Banki Range and concerned Tahasildar and should be enclosed to the DP.
10. Check list should be properly filled in mentioning the Page numbers and all necessary undertakings required as per Check list enclosed.

You are requested to comply with the above deficiencies and re-submit the Diversion Proposal complete in all respect immediately for taking further action at this end.
