Subject: Diversion of 0.671 hectare (revised from 0.727 hectare) of forest land in Kadgarni, Ullavai and Amboli villages, Joida Taluk, Uttara Kannada District (Dandeli Wildlife Division) lor Laying of Water Pipeline (265 mm internal dia) and construction of Jack well and ancillary components lor filling of Vyanginakere. Veerbhadreshwara kere and Shivatirtha kere Tanks in Kadagarni and Ullavi Villages with water sourced from Kaneri River near Amboli Village for the purpose of Irrigation, Drinking Water and Ground Water recharge in favour of the Executive Engineer, Karnataka Neeravari Nigama Limited (KNNL), Kalasa Project Division. Belagavi -reg.

Sir,

I am directed to refer to state Government's letter No. FEE 61 FLL 2022 (e) dated 19/09/2022 on the above subject and to inform that if the proposal involves any submergence of forest area, the same may be included in the area proposed for diversion. Also, in case any power lines are to be drawn through the forest area for pumping of water, the same need to be included in the proposal. Accordingly, the proposal may be revised with corresponding KML files. The dimensions and drawings of the proposed weir may also be furnished.

Further, since the proposed area is part of Anshi-Dandeli National Park, recommendation of Standing Committee of National Board for Wildlife is also required for processing of the proposal under Forest (Conservation) Act, 1980.
