

Sir,

Please refer to the Government of Manipur letter No. 20.47.2021-For & Envt dated 10.02.2022 on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal forwarded by the State Govt has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The State Govt. is requested to provide following additional information for further processing of the case: -

- 1) Soft copy KML/Shape file for proposed compensatory afforestation area with GPS Co-ordinates.
- 2) In the justification submitted by the Director, Health Services, Manipur dated 9th Feb, 2022, the area is mentioned as 1.6228 ha (out of 106,813 ha actual construction area). The State Govt may clarify the actual area proposed for diversion.
- 3) Component-wise breakup of the forest land with layout map.
- 4) Built-up area of the proposed Medical College.
- 5) NPV is to be calculated as per revised rate dated 06.01.2022.
- 6) Cost Benefit analysis as per the new calculation of NPV dated 06.01.2022
- 7) Undertaking from user agency for the cost of extraction towards the trees to be felled.
- 8) This is non-site specific proposal, whether alternatives have been explored and its reasons for rejection.
