

- 4) NPV certificate submitted overwritten. The revised typed certificate to be submitted.
- 5) C.A 7/12 extract copy not submitted along with proposal.
- 6) C.A scheme not approved by concerned Dy.CF. The same to be submitted.
- 7) Cost benefit analysis report should be submitted as per Government of India latest guideline dated 06/01/2022 and current C.A model rate structure. The revised copy to be submitted
- 8) Route Alignment showing map not submitted along with proposal
- 9) Copy of the administrative approval and technical approval not submitted along with proposal
- 10) Proposal not forwarded to Nodal office through Parivesh Portal.

11) Diverted Area KML file and Non forest area kml file not submitted properly. The single polygon KML file showing 3 lines along with all properties should be submitted as per area statement. The revised KML file to be submitted.
