**सन्दर्भ:** i). State Government letter 5620-व-1-2023/7697 dated 01.12.2023.

महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से संदर्भांकित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 1.8062 हेक्टेयर वन भूमि की मांग की गई है।

2. प्रस्ताव से सम्बंधित निम्नलिखित जानकारी भेजने का कष्ट करे: -

- Density appears to be more than 0.3 for 655 trees in 1.8062 ha.
- No. of trees are 655 in the transmission line proposal. The State Government is requested to submit the details of trees that are actually required to be felled out of 655 and no. of trees proposed for lopping/chopping.
- No comments made by the DFO in his SIR against column no. 2, 3, 4 & 5.
- Administrative approval not found uploaded online.
- Diversion area of the proposed project is above then 1 ha. i.e. 1.8062 ha. & As per Van(Sanrakshan Evam Samvardhan) Adhinyam, 1980, CA scheme is to be proposed on double the degraded land ( $1.80 \times 2 = 3.61$  ha.) instead of ten times of trees are proposed to be felled. Revised CA scheme, kml of CA Site, DGPS Map and SOI toposheet of CA site need to be provided.
- Proposed KML showing forest patches but a line connected & showing alignment of the proposed transmission line is not showing, also as per google imaginary of the attached kml appears that all towers are already erected on the acquired non-forest land & the requirement for non-forest land is uploaded as nil. Needs to be justify.
