Please refer to your office memo. FC-HMR-H01 (1)/1/2023-SALE-FOREST CIRCLE HAMIRPUR dated 18-01-2024 on the subject cited above.

2. The following shortcomings are noticed which may be attended in all respect:-

1. In point No. 2, Muck management plan has been found uploaded but the certificate regarding distance of proposed area from protected area has not been found uploaded.
2. In point No, 3 it was asked to mention correct working plan prescription in part-II Para 5, but same has not given
3. In point No. 4, the detail of violation in Para 11 b& c is still not attended in part II.
4. In point No. 5, it is correct that CA is proposed in Block Plantation but CA Scheme, digital map and KML file of proposed area out of compact block be uploaded at appropriate column.
5. In point No. 6, the bill of NPV and Penal NPV is not prepared on current rate issued on 06.01.2022. Further, the bill penal NPV has been prepared for 5 years only, whereas, violation took place more than 16 years. Hence revised the NPV and Penal NPV bill as per the current rate be uploaded online.
6. The point No. 7 is still not attended.
7. In point No. 8, The Village Benefit certificate is found uploaded but the site inspection report is not in readable form.

8. In point No. 9, the report of the committee constituted for regularization of violated case as per the direction of Hon'ble High Court found uploaded but the joint inspection report attached with it is not in readable form.
9. In point No. 10, Undertaking of user agency for providing the NoC/Sale deed/ Gift deeds may be provided online.

You are, therefore, once again requested to ensure the proper scrutiny of each point of the observations so that reply could be submitted to GoI.
