
Sir,

Please refer to the State Govt letter on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980, I am directed to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980 and rules/guidelines framed thereunder and following lacking information/documents has been observed: -

1. The forest clearance status of the existing 50.430 km Miggins-Tuting road giving a brief note on the remaining 30.296 km stretch of road which has not been included in this instant proposal and to provide the relevant forest clearance letter, if any.
2. The technically approved and duly signed avenue plantation scheme.
3. To clarify on the number of trees to be felled as it is mentioned that out of 3547 Nos, 1826 Nos. is trees and 1721 Nos. is poles whereas, on the uploaded enumeration list, it is mentioned that 1721 Nos is within the girth 31-60 cm and submit the corrected enumeration list, if required.
4. The current status of mutation and notification of the identified CA site at Idu-Keba VFR.
5. The GPS-coordinates of the proposed CA area i.e., 65.32 ha at Idu-Keba VFR.
6. To submit the corrected kml/shape file of the proposed area with the actual break-up of the proposed road i.e., 44.92 and muck disposal location of 20.40 ha as the submitted kml/shape file is incorrect

7. The corrected kml/shape file of the identified CA site indicating Nos. of plots identified as the submitted GPS coordinates and kml/shape files are incorrect.
 8. The existing and proposed RoW of this proposed length of the road.
- State Govt is requested to furnish the above information to this office for further processing of this proposal.


