Sub: Diversion of 1.018 Ha (Revised from 1.388 Ha) of forest land for Construction of BT road from Vanjariguda to Geethabanda from Km 0/0 to 2/958 of Lingapur Mandal, Kawal RF, Asifabad forest Division of Komaram Bheem Asifabad District in favour of Executive Engineer, R&B division, Komaram Bheem Asifabad-Reg

Ref: The State Government's letter No. 78/For.I(1)/2022 dated 12.01.2022 and online proposal No. FP/TG/ROAD/119580/2021

With reference to the subject and reference cited above, I am directed to request you to submit the following additional documents / clarification at the earliest for further consideration of the proposal under FCA, 1980.

- (i) The proposed forest area for diversion falls in core area of Kawal Tiger reserve area, hence the approval of SC of NBWL may be obtained and submit the same.
- (ii) The Telangana State Forest Department recommended for diversion of 1.018 ha *i.e.*, length of 1851.16 m and a width of 5.50 m. However, the design and cross section of road along with component wise details like actual carriage way (BT-portion), drainage, shoulders etc within the 5.5 mtrs width have not be submitted. Hence, the detailed note on the above along with the design and cross section plan of the road clearly indicating all such components may be obtained from the User Agency and furnished.
- (iii) Special measures proposed for mitigation of impact on Wildlife is not categorically provided. Hence, the same may be re-examined and a mitigation plan may be prepared for implementation.

Above stated details pertaining to the instant proposal may be submitted at the earliest for taking further needful action please.
