महोदय,

उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि विषयांकित प्रस्ताव में निम्नलिखित त्रुटियाँ पाई गयी है। राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:

1. The User Agency shall submit an undertaking that muck will not be dumped over forest land.
2. As per DSS analysis of the proposed diversion area, the area calculation comes to 0.04 ha instead of 0.378 ha. State Govt. is required to upload the correct KML.
3. The SIR of DFO does not contains proposal details. The SIR of DFO is required to be submitted in enclosed format.
4. Alternative alignments (three) of road along with KML file and their comparative statements is required to be submitted.
5. Full KML file of road is required to be uploaded.
6. There is total 63 numbers of Quercus leucotricophora (Banj) trees marked to be felled. In this regard, site inspection report of CCF is required to be submitted.

7. State Government is requested to submit/ upload the CA scheme along with the KML file.
