Madam,

With reference to the subject cited above, I would like to inform you that the reply of withdrawal of proposal for diversion of 13.5735 ha of forest land for construction of slope flattening in connection with Agartala- Sabroom new BG Line under District Forest Officer South Tripura. The proposed additional Forest land was physically verified on dated 26.09.2019 along with SDFO Bagafa, during physical verification it was observed that given below :-

1. Slope flattening work all ready done by user agency along with retaining wall without prior approval.
2. The area was encroached with Rubber plantation, now it is free from encroachment.

Suggestion/Recommendation As user agency does not need the land anymore but however violation has been done, so if authority desires penalty may be imposed as per FCA violation. The same area can be reclaim with high density kanak kaich bamboo plantation, so reclamation cost may also be asked from the user agency.

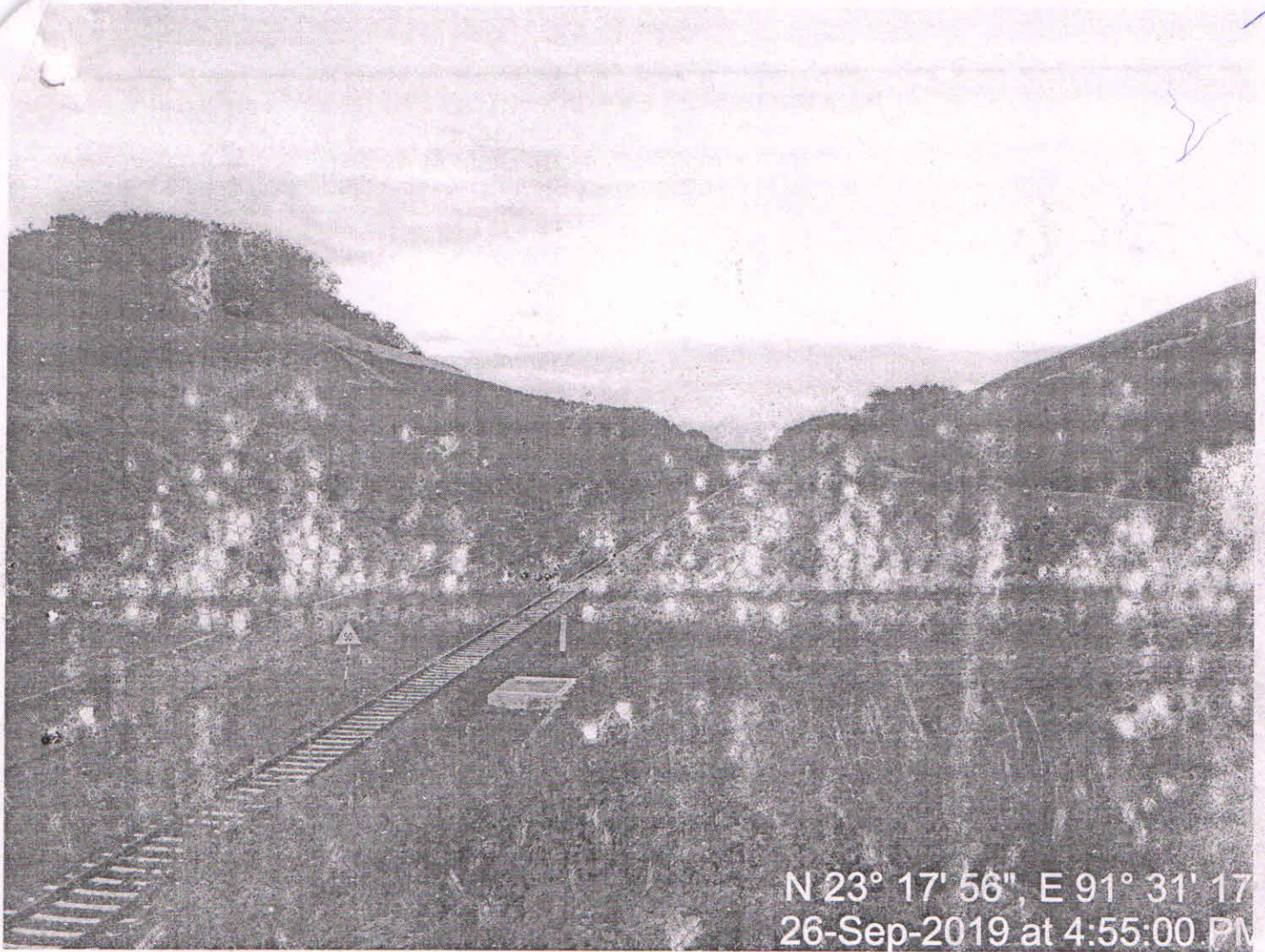
