उपरोक्त विषय पर सन्दर्भित पत्र का आशय ग्रहण करते हुए प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्न बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें। ताकि अग्रिम कार्यवाही सुनिश्चित की जा सके:-

1. State Govt. may mark the location of beneficiary villages on the KML File of the proposed road and

upload the same at para-C(ii) of Part-I. The revenue code and population of beneficiary villages may also be furnished separately.

2. It appears from the alignment proposed for diversion, the population adjacent to the starting point of

the road is already connected to existing road while to avoid dense patch of forest another alignment can also be worked out to connect the other side of village i.e. the possibility giving connectivity can IA be worked out by some other alternate alignment to reduce the felling of trees. State Govt. may submit detailed justification in this regard.

3. The non forest land is not taken for muck dumping. State Govt. may submit the detailed justification and muck disposal plan duly countersigned by DFO.

4. The density mentioned at para-4 (i) is 0.1 while the calculation provided for dense forest category.

State Govt. may do the necessary changes/correction in the density in online portal and provide it in

5. The penal NPV calculation carried out by taking amount for open forest while this should be charged as the NPV rate charged for the proposed alignment. State Govt. may clarify the discrepancy and may submit/upload the correct information.

6. As per the DSS analysis, 8 ha area of CA found in MDF. State Govt. may change CA area with

some other suitable area for plantation. 7. As per the document submitted at pg no. 9-10 of the proposal, the target habitation is Khal Tiba but VP the road has been aligned upto a point much beyond Khal. Moreover another road has also been shown in the map before Khal which has not been described/explained anywhere in the proposal. State Govt. may submit the detailed justification in this regard.

usity of vegetation is mentioned as 0.16 or 16%. The number of total tree comes to 178 tree rich will contribute density much higher than 16%. State Govt. is required to clarify the discrepancy.

Comments against para-5 of Part-II regarding 'Working plan prescription for the forest land proposed for diversion" is not appropriate. State Govt may submit the appropriate details in this regard, atleast name of working circle is required to be mentioned.

- 10. In para-12 of Part-II, it is mentioned that violation of FCA is still continuing which is a serious matter and cast aspersions on the forest officials who have failed to stop violation of FCA
- 11. Penal NPV calculation appears wrong. State Govt. may review the same as per GoI guidelines.
- 12. Eco class is mentioned as Eco class-V but keeping in view the kind of flora the eco-class is likely to be eco-class-III or IV. State Govt. may review the same and submit/upload the correct information
- 13. As per the document submitted at pg no. 90 of the proposal width of road in forest land is taken as
- UP 10.00 m and in non forest land as 3.556m which doesn't match with the total area calculated for the
- road taking length as 7000m. State Govt. may clarify the discrepancy and may submit/upload the
