विषय: Diversion of 0.56 ha of forest land in favour of Bhup Raj, 162/9 Bhojnagar Bajar Sundernagar, for the construction of Dhanwan Small HEP (1.00 MW), within the jurisdiction of Jogindernagar Forest Division, Distt. Mandi, Himachal Pradesh. (Online Proposal No. FP/HP/HYD/39107/2019)

महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए सूचित करना है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनाएं प्रेषित करने का कष्ट करें, ताकि प्रस्ताव पर आगामी कार्यवाही सुनिश्चित की जा सके:-

1. All records of consultations and meetings with Gram Sabha(s) and FRC(s) are not found enclosed with FRA certificate. The same may be provided.
2. The TEC and IA may be provided to this office.
3. The consent letter has been issued for 0.3 MW capacity. However, proposal is submitted for 1.0 MW. Therefore, comments and required documents for 1.0 MW capacity be provided to this office.
4. The comments regarding approach road to power house may be submitted. If approach road upto power house is proposed in forest land, same shall be included in proposal.
5. Population to be benefitted in the village-wise break up is not filled.
6. In KML file, one of muck dumping site is marked beyond weir site. The requirement of this dumping site beyond the project site may be justified.
7. The layout plan of project showing all components in distinct colours is required to be uploaded in PARIVESH portal.

8. In muck detail, swell factor is not applied. Therefore, same may be included in muck detail. Also, muck detail and reclamation plan needs to be authenticated by DFO concerned.
9. Purpose-wise detail of forest land showing Khasra numbers etc. is required to be submitted.
10. NoC from PWD is required to be submitted.
11. A transmission component is included in the component-wise breakup. However, detailed power evacuation plan and detail regarding transmission line is not enclosed. The same may be provided.
12. The revised NPV bill as per MoEF&CC order dated 06.01.2022 may be submitted.
13. The CA scheme of 1120 trees along with all required documents be provided to this office.
14. A map for alternate alignment has been provided with the proposal. However, reasons alongwith documentary evidence for rejecting alternate sites are required to be submitted.
15. Since ESZ of Nargu WLS has been notified, therefore exact aerial distance of proposed site from ESZ of PA be provided to this office.
16. The complete compliance report of reply shall be uploaded on PARIVESH portal (not more than 19MB).
