2. The proposal received has been found incomplete. The following shortcomings have been noticed in the proposal which are to be completed. The proposal folders received are also returned herewith for necessary corrections. All the requisite documents may please be placed in the proposal folder with proper numbering and index.

- 1. Against column C(iv), although the digital map of the proposed road has been uploaded, but the dumping sites have not been shown on the digital map. Against this column the complete digital map of the proposed road duly signed by the user agency & DFO concerned showing the dumping sites is required to be uploaded.
- 2. Against column No.G(i), Whether the Project requires Cost-Benefit analysis?: Yes, has been mentioned and cost benefit has been uploaded. But the same is not on the revised prescribed formats of GoI. Against this column the cost benefit analysis duly signed by the user agency &DFO on the prescribed formats are required to be uploaded. Prescribed formats are attached.
- 3. As per latest instructions of GoI, muck management plan /detailed muck disposal plan is also required to be uploaded against additional information details in online part-I.
- 4. In hard copy of proposal although FRA certificate in original has been placed in the proposal folder but all the proceedings are photocopies. As per instructions of GoI, FRA certificate in original and all the proceedings duly attested by the issuing department is required to be uploaded/placed in the proposal folder.
- 5. Dumping has been proposed over 0.56 ha of forest land. But the cost estimates of plantation part and engineering structures have not been found placed in the proposal folders.

6. There is difference in employment likely to be generated, mentioned against column No.E in online part-I and given in hard copy of the proposal. Against column No.E, 'No' has been mentioned whereas in hard copy of part-I against column No.1(vi), '78570' will be generated, has been mentioned. The employment details given in online part-I and placed in hard copy should match. Necessary corrections are required to be made in the employment details.
