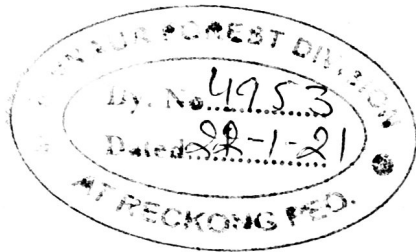
2. From the perusal/scrutiny of the case as received vide letter under reference, the following shortcoming discrepancies has been observed: -
- i) The papers/check list placed in the proposal folders has not been marked & indexed properly.
 - ii) The stamp of the Nodal officer FC affixed in the MoEF check list requires to be deleted.
 - iii) The survey sheet and digital map both for the project & CA site has not been prepared by showing all the components of the project and geo-references. The colored copy of survey sheet & digital map both be placed in the proposal folders.
 - iv) The check list No.7 placed in the proposal folders has been countersigned, whereas as per the instruction on the subject, this should have been signed by the DFO. The total area proposed for diversion has also not been shown the check list..
 - v) The check list No. 4 & 10 placed in the proposal folders are not adequate. These should be prepared by giving complete detail of area and trees involved in the alternative examined and reasons for the ~~the~~ rejection
 - vi) The colored as scanned copy of layout plan duly authenticated by the DFO be placed in the proposal folders.
 - vii) The check list No.II placed in the proposal folder has been countersigned by the DFO whereas as per instruction on the subject this should be signed by the DFO.
 - viii) The check list No.15 i.e. list of enumeration of trees has not been signed by the DFO. Please see to it.
 - ix) The case has been prepared on the old check list by the User Agency. Please see to it and prepare all the check list ~~3~~ per latest MoEF check list.
 - x) The certificate regarding the distance of Wild Life Sanctuary area has not been placed in the proposal folders.
 - xi) The General Power of Attorney with regard to authorised signatory has not been placed in the proposal folders.

Besides, some shortcoming/discrepancies observed in the revenue papers as under :-

- खसरा नम्बर 1/2 /2 का ततीमा जो काटा गया है। ततीमा में मीटर कान नहीं लिखे गये है। कितनी चौड़ाई व लम्बाई है। ततीमा में नहीं लिखा गया है। आगे जो मीटर कान खसरा नम्बर 1/2 दक्षिण मेड की तरफ 8 मीटर लिखा गया है। और मुत्वीक फिल्ड बुक में 6 लिखा जो गलत है। अब दौवारा दरुस्त किया जावे।
- खसरा नम्बर 1/2 /4 का इस्तखराज गोशा वासी द्वारा निकाला जावे ।
- खसरा नम्बर 1/2/2 , 1/2/5 को फिल्ड बुक के मुतावीक चैक लिस्ट 7 में के गैर उ० भूमिगत (सुरंग) ही लिखा जावे । तथा फलेशिंग सुरंग लिखा जावे ।
- खसरा नम्बर के आगे फिल्ड बुक में खसरा न० 6 में प्रस्तावित भूमि की किस्म सुर्ख सिहाई से लिखा जावे ।
- खसरा नम्बर 1/1/1 जो ततीमा बनाया गया है। उसका इस्त खराज रकवा नहीं निकाला गया और न ही किस्म लिखी गई है।
- जमा बन्दी में नकल खसरा नम्बर 1 की लगी है। परन्तु ततीमा में बटटे 1/1/1 से शुरु किया गया तो नकल जमा बन्दी भी 1/1 व 1/2 की लगनी चाहिए थी अब लगाई जावे ।
- चैक लिस्ट 7 में भी किसम प्रस्तावित मुतावीक फिल्ड बुक के ही दर्ज की जावे।
- Please ensure that the all check list be prepared and placed in the proposal folders as per the MoEF check list and re submit case complete in all respect, so that further be processed accordingly.
