
On scrutiny of the proposal, following discrepancies are noticed:

1. Allotment of land in favour of Central Chinmaya Mission Trust, Bhubaneswar Branch has been done vide order dtd. 26.05.2001 of the Government of Odisha, General Administration Department. In the land schedule, it is mentioned that the land is in Nayapalli Mouza. But it is mentioned in the diversion proposal that the land is coming in Paikanagar Mouza. This need to be clarified from the Tahasildar, Bhubaneswar.
2. Land schedule of the revenue forest kissam of land proposed for diversion duly authenticated by the Tahasildar, Bhubaneswar is wanting.
3. The cadastral map of the proposed forest land for diversion need to be authenticated by the Tahasildar, Bhubaneswar mentioning there in Mouza, Khata No., Plot No., Kissam and area.
4. The Topo sheet map of the proposed forest land for diversion need to be authenticated by the Tahasildar, Bhubaneswar.

5. DGPS map of the proposed forest land for diversion need to be authenticated by the Tahasildar, Bhubaneswar.
6. Check list No. 7 & 8 need to be signed by the user agency.


In view of the above, you are requested to furnish necessary compliance at an early date to facilitate processing of the proposal.


