With reference to the subject and letter cited above, I am to inform that the information furnish by the State Govt letter mentioned under reference above has been examined in this office. State Govt is requested to kindly furnish the following for further processing of this proposal:-

- The status of forest clearance for production/exploitation of hydrocarbon from KSAB and (i) KSAG as the forest clearance granted was granted only for location KSAB for drilling by Regional Office, Shillong vide letter No. 3 AS B 061/2007-SHI/1209-11 dated 12.06.2008
- (ii) State Govt to find an alternate compensatory afforestation site as the proposed CA site is having moderately dense forest and submit along with the shape file of CA in CD.
- (iii) Clarification and confirmation of the requirement of infrastructure development components as mentioned in the CA scheme.
