On scrutiny of the above Diversion Proposal, the following deficiencies are noticed.

1. Check list should be properly filled in mentioning the Page numbers and all necessary undertakings required as per Check list should be enclosed.
2. All papers/pages should be signed by the Authorized Signatory of the User Agency.
3. The Letter of technical approval of the Project should be enclosed.
4. Certified that the status of total in the Project (Both forest and non-forest) as given in the table is as per Govt. records as on 25.10.1980.
5. Compensatory Afforestation (CA) Scheme should be attached along with DGPS maps in Diversion Proposal.
6. Undertaking/FRA certificate is not attached.
7. Topo sheet map should have authenticated by Range Officer.
8. Index map should have authenticated by Range Officer.
9. Lay out map should have authenticated by Range Officer.
10. All the necessary undertaking should be attached.
11. 3 alternative Route analysis Map should be attached.
12. Serial wise checklist numbering should be done.
13. The applied area shown in the Topo sheet Map should be signed by the User Agency and authenticated by the Range Officer concerned.
14. The Layout plan should be authenticated by the concerned Range Officer and concerned Tahasildar and enclosed to the Diversion Proposal.

You are requested to comply with the above deficiencies and re-submit the Diversion Proposal complete in all respect immediately for taking further action at this end.


