As informed in the Government letter cited, for the proposals involving area up to 1 ha subject to minimum of 100 trees is to be undertaken in degraded forest land. Hence compensatory afforestation may be proposed in degraded forest area and details of CA scheme (kml file, Geo-reference map, location of CA area in Survey of India topo sheet, Site suitability certificate and CA scheme estimate) may be uploaded in the Part-II of Form-A and resubmit the proposal in parivesh portal immediately.

I am directed to invite attention to your letter 5th cited and to state that as Madurai district is having a forest cover of 13.83% only, the special provisions under chapter 2.5(i)(g) as mentioned in your letter 5th cited will not be applicable. However, it is clarified in the reference sixth cited that as per the provisions of guidelines issued by the Government of India, Ministry of Environment, Forests and Climate Change, New Delhi in its letter dated 21.08.2023, the proposals involving area upto 1 ha. are exempted from raising Compensatory Afforestation, however in such cases plantation of 10 times project affected trees, subject to minimum of 100 trees is to be undertaken in degraded forest land.

2. I am, therefore to request you to re-submit the proposal as per the clarifications issued by Government of India in the reference 6th cited to Government immediately, for further consideration of the proposal.
