महोदय,

उपरोक्त उपरोक्त संदर्भित पत्र द्वारा प्रस्तुत प्रतिउत्तर का ध्यानपूर्वक अवलोकन करने के पश्चात प्रस्ताव में अभी भी निम्नलिखित कमियां पाई गई हैं:-

1. The UA has submitted the revised layout plan/documents with all required components both in forest and non-forest land in district colures. However, components in Non-forest land has not been mentioned in the Part-I, Para- B-2.4-Component wise breakup. Same may review and rectify the same.
2. KML files/digital map showing location of approved/existing/proposed proposal in the river basin area/landscape HEPs and their distances from nearest PA and their final/draft notified ESZ as mentioned in MoEF & CC, OM dated 13.05.2022 may be provided/uploaded on the PARIVESH portal.
3. Part-II, column-14, geographical area of district may be reviewed and rectified.
4. State Govt. has submitted that Legal status of proposed area is "CHARAGAH VILLA DRAKHATAN" and it is Govt. Waste land declared as PF under HP Govt. notification, 1952 is in possession of H.P Forest department. However, in Part-II, Para-II, para-5, Working Plan prescription, it is mentioned as "Neither prescribed nor suggested". Therefore, State Govt. may provide the documentary proof the DA area is under the possession of HP forest department.

If the Shortcomings/observations raised by this office are not satisfactorily complied, the proposal shall be summarily rejected.
