- 2. You have submitted undertaking for complete diversion of 14.15 Ha. Forest land, however 3.31 Ha. land falls under the jurisdiction of West Forest Division (need to submit the undertakings for 3.31 Ha. only).
- 3. You have submitted 14.15 Ha. Compensatory Afforestation land, however 3.31 Ha. land falls under jurisdiction of West Forest Division.(need to be submitted 3.31 Ha. land)
- 3. Some part of the land proposed for Compensatory Afforestation is densely vegetated. (Need to be submitted degraded forest land).
- 4. The land proposed for Compensatory Afforestation is falls on road from village Dhulsiras to Pochanpur which is mentioned in the Affidavit filed before Hon'ble Court by the Conservator of Forest. Identification of the same is under process.(The Compensatory Afforestation land shall be considered after identification of the Protected Forest Land).

You are requested to upload the aforementioned documents on Privesh Portal and 4 copies in the office of undersigned so that proposal can be processed at earliest.
