I am directed to refer to State Government's letter No.5141781/FR.10/2023-2 dated 07.12.2023 on the above subject and to request that information on the following may kindly be provided:-

- i. Since the proposal involves felling of 343 trees of spontaneous origin, the State Government may revise the width of the road to 6 m by restricting the tarring portion to 3.75 mtrs. In curves, the actual technical area required may be considered. Accordingly, the revised requirement of area may be furnished with revised KML files, number of trees to be felled etc.
- ii. The Compensatory Afforestation area proposed in non-forest land in Sy No 692/6 of Kammampatty and degraded forest area in Parigam-B RF is not found suitable during the recent site inspection carried out by the officer from this office. Therefore, the non-forest land may be obtained in lieu of the proposed diversion but for planting in degraded forest land alternative suitable degraded forest land for planting of sufficient seedling preferably with less than 40% crown density may be identified and the details of the same viz KML file, map. revised CA scheme etc. may be furnished.
