The bill of NPV has not found placed in proposal folders, the NPV bill on current rates may be placed in proposal folders.

As per the certificate issued by GP Madhodgar as uploaded in Part-I against the additional column there is a violation in the present proposal and an amount of Rs. 2,35,200/- stated to have been spent on the said road. As per the joint inspection report the said road is existing road and same can ascertain from the KML file of the proposed road. Whereas, DFO concerned in his site inspection report has mentioned that there is no violation in the present proposal and 'No has also been mentioned in the 11(i) column of online Part-II. Further, nothing has been mentioned in this regard against the column No. 9 in part-II of hard copy. The detailed report on the violation be submitted in this office and reason for not revealing the facts in site inspection report may also be submitted in seprately.
