Sub: Proposal for diversion of 34.9816 ha of forest land for widening/improvement of existing road Namti-Kibithu from 0.00 km to 20.31 km to NHDL specification by BRTF in Anjaw District of Arunachal Pradesh.

Sir,

Please refer the State Govt letter on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. I am directed to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980 and rules/guidelines framed thereunder and the following lacking information/documents has been observed:-


1. To clarify on proposal name mentioned at Part-II Form as the proposed 34.9816 ha is mentioned as for widening/improvement and realignment of existing road Namti-Kibithu between km 0.00 to 20.310 to NHDL specifications as well as for construction of road Kibithu-Thochu-Wacha between km 0.00 to km 9.750 (Green field alignment).
2. The aerial distance of the proposed area from the nearest boundary of Protected Area/Wildlife Sanctuary/National Park.
3. The technically approved avenue plantation scheme and its estimation.
4. The original or colour scanned Sol map indicating the distance of the proposed road to the proximity of the nearest river.
5. The comments of the State Govt on the muck dumping locations as 2 Nos. out of 5 Nos. identified muck dumping sites area are 'INVIOLATE' due to presence of hydrological layer as per the DSS.
6. The identified 35 ha CA area comprises of 4 ha very dense forest, 4 ha moderately dense forest, 26.061 ha open forest and 3.008 ha non forest as per DSS. State Govt is therefore to conduct site inspection of the identified CA area by an officer not below the rank of Conservator of Forest and report to be submitted mentioning vegetation and forest cover density with photographs of the inspecting officer taken at the site, or else, an alternate CA site is to be submitted along SOI maps, site suitability certificate, GPS-coordinates, shape file etc.



7. The table indicating area wise, lengthwise, existing and proposed RoW, whether for widening/ improvement/new alignment etc.
8. The original or colour scanned SoI toposheet indicating the identified CA area as the uploaded map is not legible.

State Govt. is requested to kindly furnish the above requisite information to this office for further processing of this proposal.


