With reference to the subject and letter cited above, I am to inform that the information furnished by the State Govt letter under reference above has been examined in this office and following lacking information has been observed:-

- (i) State Govt is to provide the status of forest clearance for production/exploitation of hydrocarbon from NRAA as the forest clearance granted by Regional Office, Shillong letter No 8-12-37/2000/RONE-AS/429 dated 08.08.2002 is for exploratory drilling only. The date from when the commercial/ exploitation has started is to be provided as the Stage I was granted prior to Ministry guideline F.No.11-423/2011-Fc dated 30.09.2019.
- (ii) The original or colour scan SoI map indicating the proposed CA area with proper title of the map.
- (iii) To submit technically approved and duly signed CA scheme of the proposed alternate CA site as the submitted CA scheme is not legible.
- (iv) The soft copy of the shape/kml file of the proposed alternate CA area is to be submitted.

 State Govt is requested to furnish the above information to this office for further processing

of this proposal.
