Sub: Proposal for diversion of 0.03 ha of forest land of village Madhapur under Athgarh Tahasil of Cuttack District for installation of High Power Transmission Line connected from the tapping point at Champia to Arati Steel Ltd. for fulfillment of additional requirement of power by M/s Arati Steel Ltd. Ghantikhal under Athgarh Forest Division (Proposal No.FP/OR/Trans/41322/2019, State Serial No.OR-096/2021 dated 18.12.2021)

Ref: Your office Memo No.5416 dated 23.12.2022

In inviting reference to your aforesaid office memo on the captioned subject, this is to inform you that during the course of checking of the above proposal the following discrepancies have been noticed.

- (i) Financial & technical sanction order/ approval order of the project is to be furnished with the DP.
- (ii) Topomap showing 2 Nos. of alternative routes surveyed by M/s Arati Steel Ltd. for laying of such high power transmission line for which barest minimum forest land shall be required and final selection of route depending upon various parameters of selection has also not been enclosed with the DP.
- (iii) Part 'A' regarding FRA requirement is to be rectified.
- (iv) Non-forest land requirement for the project has been shown as 16.85 ha and of forest land 0.03 ha in the Site Inspection Report of the DFO, Athgarh Forest Division enclosed at **Page No.16-17/DP.**

Whereas, as per land schedule of both forest and non-forest land requirement for this project duly authenticated by both the DFO and Tahasildar concerned enclosed at **Page No.26/DP** has been shown as 16.88 ha. So, the discrepancy noticed over the non-forest land requirement as per Site Inspection Report and as per land schedule is to be rectified.

In view of the above, the diversion proposal in triplicate are returned herewith for necessary compliance at your end and resubmission of the same to this office at the earliest for taking further necessary action at this end.
