The Chief Conservator of Forests (T), Thane vide letter dated 25/01/2023 has submitted proposal for diversion of 0.0399 ha. of Protected Forest land for construction of Railway over bridge in lieu of level crossing 6 at Railway Km 63/400 on Diva-Vasai Section Railway line at Kharbao, Tal. Bhiwandi, Dist. Thane in the State of Maharashtra. The said proposal has scrutiny to this office following discrepancies has been observed in the said proposal:-

- 1) Diverted area KML file has been observed to this office. The starting points and ending points along with properties as per area statement not showing in KML file. Rectification to be needed.
- 2) Non Forest area polygon should be shown in different color. Rectification to be needed.
- 3) 3 alternative alignment KML file should be submitted.
- 4) The copy of the C.A 7/12 extract not submitted along with proposal.
- 5) As per area statement diverted area showing 0.0399 ha. instead of Part-I area showing 0.04 ha. rectification to be needed in Part-I
- 6) Copy of the Part-I of User Agency, name of authorized signatory, date and place not mentioned. Revised copy to be submitted.
- 7) User Agency all undertaking given without showing of name of authorized signatory, date and place. Revised undertaking to be submitted.
- 8) User Agency all undertaking has diverted area mentioned wrongly. Revised copies of the same to be submitted.
- 9) Final notification of Tungareshwar Wildlife Sanctuary to be submitted.
- 10) C.A scheme not signed by Dy.CF, Thane.
- 11) Area Statement not signed by the Dy.CF, Thane
