While resubmitting the proposal, the user agency has uploaded some additional documents in the Part-I of Form-A. However signed hard copy of Part-I of Form-A in duplicate has not been furnished in the Conservator of Forests and Field Director report.


The Conservator of Forests and Field Director is requested to send the signed hard copy of the updated Part-I of Form-A in duplicate urgently.
