Subject: Diversion of 2.121 Ha of Forest land for formation of approach road for construction of HLB across Manjeera river from Dharmareddy to Muddapur via Venkampally road PR road in Kamareddy District in favour of Executive Engineer, R&B Division Kamareddy-reg

Reference: The State Government letter No. 1587/For.I(1)/2021 dated 15.06.2021 and online proposal No. FP/TG/ROAD/31490/2018

Madam,

With reference to the subject and reference cited above, I am directed to request to submit the following additional documents / clarification etc at the earliest for further consideration of the proposal under FCA, 1980;

- (i) The User Agency reported that the existing road is constructed prior to 1980. However, the State government had not provided details of RoW including length and width etc and also not submitted supporting documents like RF notification mentioning the RoW etc. Hence detailed report on the above matter along with supporting documents may be provided.
- (ii) The District Forest Officer. Kamareddy reported that the UA has not carried out any work in violation of FCA, 1980. However, as per the kml file, some activities /structures are visible. Hence it is requested to clarify the same.
- (iii) Cross section of the road with clearly indicating component wise details like actual carriage way (**BT-portion**), drainage, shoulders etc may be submitted.
- (iv) There is a deviation taken from the existing road within forest area which could be avoided if the existing road is used. Hence, this portion may be realigned along with the existing road.
- (v) Part-II of the proposal duly filled in and signed by the DFO concerned is required to be submitted as per FC Rules, 2003 (amended upto 2007).
