With reference to the subject matter, it is toinform that the instant proposal was placed before Regional Empowered Committee (REC) meeting held on 06/08.02.2024. After thorough examination of the proposal, the committee noted that the User Agency proposed degraded forest area for Compensatory Afforestation purpose. However, as per the Van (Sanrakshan Evam Samvardhan) Rules 2023 adopted w.e.f. 01.12.2023 under sub rule (16) (8) (ii), the instant proposal further to be processed as per the provision of new Van (Sanrakshan Evam Samvardhan) Rules 2023 and the UA is required to provide suitable Non forest area for CA purpose in place of Degraded Forest Land (DFL). In view of the REC decision, I am herewith directed request the State Government to identify suitable non forest area for CA purpose and submit required CA scheme, soil suitability, map, kml file etc through online at the earliest for further consideration of the proposal.
