With reference to the subject and reference cited above, it is to inform that, along with the recommendation of the Regional Empowered Committee (REC), the subject proposal file was forwarded to the MoEF&CC, New Delhi seeking ex post facto approval from the competent authority;

2 With the approval of the competent authority, MoEF&CC, New Delhi, returned the proposal file to this office and directed to take action under 3A or 3B on violators before issuance of Stage-I.

3 Accordingly, I am directed to convey under provision of sub rule 15 (1) & (2) of the **Van (Sanrakshan Evam Samvardhan) Rules 2023**, that the jurisdictional Divisional Forest Officer or Deputy Conservator of

Forests as the case may be to initiate action under 3A or 3B of **Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980** on violators by filing complaint (s) against such person or authority or organization, prima-facie found guilty of offence under the Adhiniyam and rules made there under, in the court having jurisdiction in the matter **within 45 days** from the date of receipt of this letter.

4 Further, the State Government and authorities concerned shall submit a periodic progress report to Regional Office, Nagpur, from time to time, regarding the compliance in the said matter.
