Sub: EDS with respect to Proposal No. FP/JK/ROAD/146352/2021 regarding FCA proposal "Operational Track from Chand (BEND) to SEB by 21-KUMANO (Army) in J.V. Forest Division.

In context of the above captioned subject, you are directed to provide following essential documents/information enabling the undersigned to process the FCA proposal under the Forest (Conservation) Act, 1980.

1. The KML of degraded forest area proposed for Compensatory Afforestation and KML of Forest area proposed for diversion are same, Divisional Forest Officer need to upload correct KML of degraded forest area proposed for CA.
2. **Compensatory Afforestation site** as per CA scheme/CA site approval uploaded is in compartment 58 Uri Forest Range, while as the CA site mentioned on PARIVESH Portal under "**Patch wise Details**" in **PART-II- FORM-A, S.No. 13**, is in compartment 60/Uri, Divisional Forest Officer need to do the necessary corrections.
3. CA Site approval is a separate document that need to be uploaded by Divisional Forest Office in "**Additional Documents Section**" in **PART-II- FORM-A on PARIVESH Portal**, that needs not to be mixed with the CA Scheme.
4. Divisional Forest Officer need to upload correct **Geo-referenced map** of Degraded Forest Area proposed for Compensatory Afforestation.
5. (**Land Suitability Certificate**) Certificate in respect to suitability regarding area proposed for CA (degraded forest land/ non- forest land) suitable from management point of view need to enclosed as per the format (Circular along with format already communicated to all DFO vide this office communication No. FD/CFN/FCA/1684-87, dated: - 29/01/2021.)
6. Divisional Forest Officer need to upload "**NPV calculation**" as per revised NPV rates.
7. "**NPV calculation**" and "**CA Calculation**" are two separated documents that need to be uploaded separately on PARIVESH Portal as two documents.
8. **Area calculation sheet** uploaded by Divisional Forest Officer is not correct.

9. Divisional Forest Officer need to recheck whether the process of **Forest Rights under the FRA 2006** on the forest land proposed for diversion has been completed. If yes then User Agency need to upload FRA correspondence letter on its designated place on *PARIVESH Portal i.e., FORM-A, PART-I Serial No. K.*
10. User Agency need to upload "**Administrative Approval of the Project**" in Additional Information Details in PART-I, FORM-A.
11. The User Agency need to upload ideal "**Layout map for construction/ improvement of roads**" in UT of Jammu & Kashmir and Ladakh, as already communicated to all Divisional Forest Officers vide this office communication No. *FD/CFN/FCA/1533-36; Dated: - 06/01/2022.*


