महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करते हुए आपको यह सूचित करना है कि राज्य सरकार द्वारा बिंदु संख्या 1 के प्रतिउत्तर में प्रदान की गई सूचनाएं त्रुटिपूर्ण पाई गई हैं। अतः राज्य सरकार उक्त बिन्दुओं पर मांगी गई सूचनाओं के साथ-साथ पर निम्नलिखित अतिरिक्त सूचनाएँ भी प्रेषित करने का कष्ट करें, ताकि प्रस्ताव पर आगामी कार्यवाही सुनिश्चित की जा सके :-


1. In the forwarding letter of the State Government, it has been mentioned that the 12 trees and 6 saplings are to be cut /felled. However, the general abstract of the trees shows that the 6 trees and 12 saplings are to be affected. Therefore, State Govt. may review and rectify the same accordingly and upload the same on PARIVESH portal.
2. The proposed project is located in the Core/Green belt area / within the limit of the MC Shimla and 12 valuable trees like Ban, Kail etc. are being affected. Therefore, State Govt. may provide the comments on the view of the Order of the Hon,ble Supreme Court of India, NGT and High Court of Himachal Pradesh in this regard.
3. Part-II, Para 6, it is mentioned that no vulnerability of forest area to erosion. However, Part-II, Para-7(viii) shows that the forest area is slightly vulnerable to erosion. Therefore, State Govt. may provide the comments regarding vulnerability of the adjoining land/forest areas to the accelerated soil erosion after or during execution of the project and mitigation measures for the same. Additionally, comments may also be provided for overall strategies to be adopted for the ecological restoration of adjoining forest/land areas along the proposed area, if applicable.



4. The submitted CA scheme for Compensatory Afforestation has not been prepared as per the guideline of the FC handbook. Therefore, State Govt. may submit/upload the revised CA scheme to plantation for 420 plants along-with plantation model and maintenance cost to be charged for 10 years.
5. According to the KML, the proposed project site has directly access/approach from NH-205. Therefore, State Govt. may provide/upload the NoC issued by the competent authority for direct access/approach route for the same.
6. State Govt. may provide/upload the revised NPV calculation sheet in consonance with MoEF & CC memorandum dated 6.2.2022.
7. Since the project is a Non-Site Specific category and the State Government has submitted its reply on the proposal after a long period. Therefore, State Govt. may furnish their comments on the proposal as per Para 1.2 guideline of FC handbook accordingly.
8. Part-II, Para-14, the geographical area of district Shimla does not seem correct. State Govt. may review and rectify the same.
