Sir,

On scrutiny of the above diversion proposal, the following deficiencies are noticed.

- Form No.1 prescribed in the Forest (Conservation) Rules'2003 duly filled in by the Applicant should be enclosed. Besides, blank Forms, i.e., Form No.II, III, IV, & V should be enclosed.
- 2. The Check List should be properly filled in and enclosed to the Proposal.
- 3. No Objection Certificate should be obtained from the Collector, Sundargarh under the Forest Rights Act'2006 and enclosed to the proposal.
- 4. Authenticated DGPS Map has not been submitted.
- 5. Non-forest land for Compensatory Afforestation has not been provided.
- 6. Lease Profile has not been submitted.
- 7. The status of land as on 25.10.1980 and the required certificate have not been provided by the Tehsildar, Koira.
- 8. The land schedule of non-forest land of the Revenue village with abstract and grand abstract signed by the User Agency, and the Range Officer, Koira, DDM, Koira and Tehsildar, Koira should be enclosed in the following proforma.

- 18. Map showing Proposed Land Use (Plate No.V) should be submitted signed by the Applicant and authenticated by the Tehsildar, Koira DDM, Koira, and Range Officer, Koira.

Besides, a Proposed Land Use plan in Revenue Sheet showing item-wise use of the project land signed by the Applicant and authenticated by the Tehsildar, Koira DDM, Koira, and Range Officer, Koira should be enclosed.

- 19. Undertaking to the effect that the Applicant shall deposit all Compensatory Levies as per Conditions imposed by the MoEF & CC, Govt. of India as well as by the State Government should be enclosed.
- 20. Application should be filed before the Competent Authority for issue of Environmental Clearance, and proof of the same should be enclosed.
- 21. The Reclamation Scheme, Map and schedule of reclamation authenticated by the DDM. Koira should be furnished.
- 22. The Mining Plan is incomplete as the accompanying Maps have not been furnished
- 23. The Cost Benefit Analysis is to be prepared as per new guidelines issued vide Letter No.7-69/2011-FC (pt) dt.1.8.2017 of the MoEF & CC, GoI and enclosed to the Diversion Proposal.
- 24. The Proposal should be Page-numbered serially with Annexure numbering.

You are requested to comply the deficiencies and re-submit the proposal early.
