Sir,

With reference to subject and letters cited above, I am to inform that the information furnished by the State Govt letter under reference (i) above has been examined in this office but found incomplete. State Govt is requested to kindly furnish the following information to this office for further processing of this proposal: -

- (i) The revised enumeration list of the trees to be affected by this proposed area as the number of trees submitted is different from the earlier submitted enumeration list.
- (ii) The Ministry letter F.No. J-11011/294/2017-IA-II(I) dated 06.09.2018 stated that  
"Only those projects, where the pipeline is passing through National Park/Sanctuaries/coral reefs/ecologically sensitive areas, shall be required to obtain the prior environmental clearance".

State Govt is therefore to provide the current status of Environment Clearance of this instant proposal as the proposed natural gas pipeline passes through Eco sensitive zone of Amchang and Pobitora Wildlife Sanctuary as per letter No.B/GWL/IGGL/2021/255 dated 10.02.2021 of Divisional Forest Officer, Guwahati Wildlife Division.
