महोदय.

उपरोक्त विषयान्तर्गत सन्दर्भित पत्र का आशय ग्रहण करते हुए मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरांत निम्नानुसार कार्यवाही राज्य सरकार स्तर से अपेक्षित है:—

- 1. The area marked for muck dumping i.e. 0.12 ha has not shown in the village wise breakup at Para B 2.3 in online Part-I. Therefore, the state govt. may ensure that the muck dumping area has been shown in the village wise breakup at Para B 2.3 in online Part-I.
- 2. The proposed area is within 10 Km of nearest Protected Areas. Therefore the comments of CWLW on requirement of animal passage Plan etc is required to be submitted by the state govt.
- 3. State Govt. may mark the Location of population proposed to be benefited by this road in KML at para C.
- 4. State Govt. may submit the Penal NPV calculation after incorporating 12% interest from the year date of violation to the date till deposit is made for the broken area.
- 5. DSS analysis of proposed CA shows that area 1.00 ha area falls in MDF. Therefore, the State Govt. may replace this CA area with some other suitable area having crown density below 0.4 and @1000 tree/ha can be planted as per the guidelines.
- 6. The area proposed for dumping is 0.12 ha in forest land. Hence, the state govt. may shift this area to non-forest land and provide separate enumeration list of trees for this 0.12 ha forest area to this office.
- 7. State govt. may submit the detail of length and width for the broken area.
- 8. Administrative approval is for 6.0 km while the road is being constructed for 6.223 Km. Further, at one place bifurcation of the road is being proposed required to be justified in view of administrative approval.
