

The undersigned is directed to refer to Government of Maharashtra letter No. FLD-2022/C.R.273/F-10 dated 24.11.2022 on the above subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980 and to say that preliminary scrutiny of the proposal in the Integrated Regional Office, MoEF&CC revealed following:

- Name of signing authority is not mentioned in Part- I submitted along with the proposal. Revised Part- I mentioning name of signing authority and date of submission shall be submitted.
- Part-IV and Specific recommendation of PCCF (HoFF) is not submitted along with the proposal. The same needs to be submitted in original.
- It is mentioned that laying of underground OFC duct and cable is within RoW of existing MDR-63 road i.e. Satara-Patan-Aral route. Status of the said road shall be submitted along with compliance report.

In view of the above, I am directed to request the State Government to submit information on the shortcomings, as indicated above, to this Ministry for further consideration of the proposal for approval under the Forest (Conservation) Act, 1980.

This issues with the approval of DDGF(C)/ Regional Officer (Central), Integrated Regional Office, MoEF& CC, Nagpur.
