




**Sir,**

On dated.23.08.2023, while the undersigned was on tour to Gania Range for inspection of waterbody in Makarprasad RF, it was found that one tower was installed in Khesara Forest area with GPS reading N 20.413462, E 84.831998 without issue of work order from competent authority which violates the provision of FCA, 1980.

During the site inspection, you have not shown the undersigned entire sites proposed for installation of tower and only taken to those areas where there was no tower proposed. Being Khesra forest it is difficult for the undersigned to find out the exact land status during site inspection. You have also mentioned that there is no tower installed in any forest area. This shows you have intentionally and knowingly misled the forest department, about the violation of Forest Conservation Act,1980 done by you.

Hence, you are hereby asked to explain why necessary action will not be initiated against you for violation of Forest Conservation Act,1980.


Sir,

With reference to the above cited letter on the captioned subject, it is being brought to your attention that, as per the guidelines of Ministry of Environment forest & Climate Change Govt. Of India letter No. 11-42/2017-FC dated. 29.01.2018" in case where the proposal under FC act, 1980 has not been submitted and Forest land has diverted without FC Act in the state will be dealt under the provision of India Forest Act, 1927 or State Forest Act on any other state Act dealing with such land".

During the site inspection of the undersigned to Gania Range on 23.8.23 violation has been noticed by OPTCL (as they have constructed towers on revenue forest land) for which they have been noticed vide letter no 6705 dated 25.8.23. The fact was also reported from the IRO office, Bhubaneswar regarding irrection of 18 no of towers over forest land (status revenue forest).

As the violation report belongs to Revenue Forest ( List enclosed herewith for your information and necessary action ),you are requested to take necessary action against the erring officials under OPLE Act or any other act in force at the point of time and submit action taken report to this office for record and communication to high quarter.






