

Sir,

The undersigned is directed to refer to State Government, Maharashtra letter no FLD-1920/C.R.153/F-10 dated 03.06.2021 and APCCF and Nodal Officer (FCA), Maharashtra vide letter no. Desk-17/NC/II/ID 12740/(19)/16/2019-20 dated 15.05.2020 on the above subject seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980 and to say that preliminary scrutiny of the proposal in the Integrated Regional Office, MoEF&CC revealed following:

- i. Proposal has not yet been forwarded to Regional Office through online portal and is still pending at State Government level (online status as revealed on 19.08.2021 at 12.15 hrs).
- ii. Consolidated single KML file of entire alignment under instant proposal, dully highlighting proposed forest area for diversion has not been submitted. The same needs to be submitted.
 - iii. Date of submission is not mentioned in Part- I and Part- II submitted along with the proposal. Revised copy of Part- I and Part- II mentioning name of signing authority and date of submission shall be submitted.
- iv. Discrepancy is observed in area of non-forest land involved in the proposal. State Government has mentioned in its covering letter that an area of 0.3015 ha of non-forest land is involved, whereas in online Part- I area of non-forest land is mentioned as 0.00 ha. Clarification in this regard shall be submitted.
 - v. Legal status of Forest land proposed for diversion is mentioned as 'NIL' in online Part-II application. The same shall be rectified by concerned DCF and copy of the same shall be submitted.
- vi. Part- II has been wrongly uploaded in Parivesh portal, instead of hard copy of Part- II,
 Site Inspection Report has been uploaded. The same shall be rectified by concerned
 DCF and intimated to this office.

- vii. Part- V has not been uploaded in Parivesh portal. The same shall be uploaded and intimated to this office.
- viii. Physical copies of Part- III, Part- IV and Specific recommendation of PCCF (HoFF), Maharashtra is not submitted along with the proposal. The same shall be submitted.
- ix. Online Part- II is incomplete, information of Compensatory Afforestation and district profile details is left blank in online Part- II, the same shall be filled by concerned DCF and copy of the same shall be submitted.
- x. Cross sectional map is not submitted along with the proposal. The same shall be submitted.
- xi. All the maps submitted along with the proposal is not certified by competent authority in the Forest Department. Maps certified by concerned DCF shall be submitted.
- xii. Compensatory Afforestation scheme is submitted only for 7 years. As per Section 2.8 (ii) (e) of new guidelines, CA scheme should be submitted for 10 years. Therefore, revised CA scheme for 10 years along with provision for chain link fencing of CA area shall be prepared and submitted along with CA suitability certificate, soft copy of KML file and hard copy of Differential GPS map at suitable scale certified by officer not below the rank of DCF.
- xiii. Certificate ensuring importance of Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 is not submitted along with the proposal. Original FRA- 2006 certificate along with documentary evidences in the form of copies of the resolutions of the concerned Forest Rights Committee(s), Gram Sabha(s), Sub-Division Level Committee(s) recording their consent for the proposal and bearing signature of the participants shall be submitted. In addition to this, copies of record of proceedings of the Forest Rights Committee, Sub Divisional Level Committee(s) may also be submitted.
- xiv. Details of employment potential in terms of man days of skilled, semiskilled and unskilled persons on permanent (direct and indirect) and temporary (direct and indirect) basis have not been provided. The same needs to be provided by the State Government.

In view of the above, I am directed to request the State Government to submit information on the shortcomings, as indicated above, to this Ministry for further consideration of the proposal for approval under the Forest (Conservation) Act, 1980.

This issues with the approval of Regional Officer (Central), Integrated Regional Office, MoEF & CC, Nagpur.
