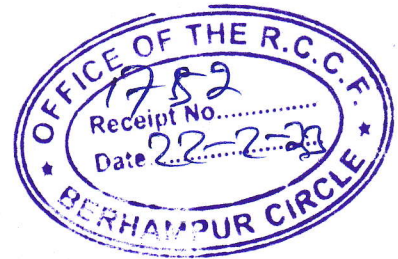

In inviting reference to the subject cited above it is to inform that during scrutiny of the project proposal, the following discrepancies were noticed which require compliance for further processing at this level -

1. **Non-Forest land Involvement** - As per Part-I the non-forest land required for the project is 0.901 ha. under two villages of Jagannathprasad Tahasil but as per land schedule is 0.893 ha. The User Agency/DFO to clarify the actual requirement.
2. **Length of project road** - Divisional Forest Officer to clarify whether Improvement & Black Topping has to be done in the existing Road from PWD Road to Siuli village is over 10.320KM or 12.516 KM.
3. **Tree enumeration** - Tree enumeration contradicts in the approved two lists i.e in one list it is shown to be 592 trees & 30 nos. of bamboo Culm. & in another list (site inspection) it is shown to be - 521 trees & 21 Nos. of Bamboo Culm. DFO to clarify and furnish the corrected list.
4. **Status of land schedule as on 25.10.80** - Not furnished by the Tahasildar Jagannathprasad Tehsil.

5. **D.S.S. Study report** - The DSS study report of the CA land has not been countersigned by the RCCF, Berhampur circle.
6. **FRA Certificate** - The User Agency has applied before Collector, Ganjam over 1.733 Ha. of forest land as per previous part-1 Report. Now the applied area is 2.562 Ha. of Forest land. Therefore, a copy of fresh application for FRA Certificate over 2.562 ha. and an undertaking regarding submission of FRA Certificate need to be submitted.
